Information for those seeking spiritual clarity on the subject of Covid-19 vaccination.

What really is vaccination? How should we classify it? What reasoning, if any, necessitates the procedure? What is the proper scriptural view to take in regard to it? Does science really demonstrate a need for it? We shall endeavor to answer these questions, and in the process, take a hard look at its proponents – those directly involved in it and those who indirectly occasion the practice through their claims and assertions.

Additionally, because it is a popular feature of the world, we must also consider the condition of the world and under whose influence it functions. The world, being the system of human activity, cannot be viewed as something that has changed over time insofar as human nature is concerned. Technological advancements have done nothing to alter the fundamental human condition. If anything, the technological advancements have provided greater opportunity for its enhancement.

So who really rules the world? Let us consult the biblical teaching and proceed from there to answer the other questions.

It is a fundamental Biblical doctrine that Satan is the ruler of this world. Numerous scriptures support this conclusion: John 14:30, John 12:31-33, Ephesians 2:1-3, Ephesians 6:12-13, John 16:11, John 8:44-47, 1 Peter 5:8-10, Matthew 4:8-9, Luke 4:5-6, Hebrews 2:14, James 4:4, and 1 John 5:18-19.

Jesus told the Jews, "You are of your father the devil, and your will is to do your father's desires. He was a murderer from the beginning, and does not stand in the truth, because there is no truth in him. When he lies, he speaks out of his own character, for he is a liar and the father of lies." – John 8:44.

Prophecy specifically states that Satanic activity would increase during the last days, which we are living in now: "Therefore rejoice, O heavens, and you who dwell in them! Woe to the

inhabitants of the earth and the sea! For the devil has come down to you, having great wrath, because he knows that he has a short time.” – Revelation 12:12.

The objective of the Devil is to cause death and destruction. He does this by means of lies. Divination is one of the means by which lies are produced. These lies are malicious, intending to produce death through sorcery. He is a master of deception. Few are aware of how he operates because they are limited to a secular worldview or have been misled by false prophets. It requires a spiritual worldview to recognize when Satan is behind what might otherwise be considered beneficial to mankind.

This deception through sorcery was foretold to occur in the prophetic book of Revelation, whose prophecy foretold that in the last days there would be a world empire ruled by Babylon the Great, modeled after the ancient Babylonian empire. Its destruction was foretold to be a consequence of its practice of sorcery, the means by which it deceives the whole world. The Greek word for sorcery is “pharmakeia,” from which we derive our word for pharmacy.

Pharmakeia is defined, in part, by Thayer’s Greek Lexicon as:

1) the use or administration of drugs

2) poisoning

Bible believers are counseled to “prove all things; hold fast that which is good; abstain from every form of evil.” (1 Thessalonians 5:21-22) They are also commanded, “Don’t put your confidence in powerful people” (Psalm 146:3), such as those involved in sorcery, which the COVID-19 pandemic is a form of.

Time has progressed far enough to demonstrate that the COVID vaccines and possibly the PCR tests are used for the administration of drugs to poison people, regardless of the claims of the medical establishment, which is an integral part of the world. This poisoning was foretold to occur by the prophecy in Revelation concerning Babylon the Great:

“and the light of a lamp will not shine in you any longer; and the voice of the bridegroom and bride will not be heard in you any longer; for your merchants were the great men of the earth,

because all the nations were deceived by your sorcery." – Revelation 18:23.

Sorcerers are listed among those who will meet with destruction: "But for the cowardly and unbelieving and abominable and murderers and immoral persons and sorcerers and idolaters and all liars, their part will be in the lake that burns with fire and brimstone, which is the second death." – Revelation 21:8.

The medical response to the COVID-19 pandemic was authorized by emergency use, which has allowed for individuals, if they so choose, to take part in medical experiments and to use unproven procedures and test unproven drugs, namely, various COVID-related treatments and various types of vaccines.

It is presumptuous to participate in these experiments and expect positive results. The Bible's counsel is, "Keep back your servant also from presumptuous sins; let them not have dominion over me! Then I shall be blameless, and innocent of great transgression." – Psalm 19:13.

The Bible warns believers to beware of becoming too involved in worldly practices because, "We know that we are children of God, and that the whole world is under the control of the evil one." – 1 John 5:19.

Virology is divination, a pseudoscience rooted in germ theory and the myth of contagion. Virologists do not adhere to the scientific method in their procedures. All of their viruses are created "in silico," which is computer modeling.

The following is a general outline of what they do. To begin with, they never take an isolated viral particle from a sick person; rather, they take a sample from inside the nostrils and presume that the virus is in the sample. Then they add the sample to a cell culture, combine it with numerous other ingredients, subject the culture to more procedures, and wait for the cells to die, which they call the "cytopathic effect" and claim its cause is the presence of a virus.

Then they take the dead cell debris and image certain sized particles under an electron microscope, which they claim are virions. Nevertheless, these so-called virions cannot be distinguished from extracellular vesicles, some of which are called exosomes. Neither can they prove they were ever in the sick person to begin with. Furthermore, they cannot prove they are

not the product of their procedures. Nor can they prove they cause disease.

To create the alleged virus' genome, they collect genetic fragments from cell breakdown products contained in the culture, obtain their sequences, and enter the information into a computer. The software then aligns the sequences to a template, although they never had an entire intact genome of the alleged virus to start with.

In a recent experiment, virologist Dr. Stefan Lanka obtained the same results without adding a sample from a sick person to the cell culture. This is called a control experiment, which the virologists themselves do not perform because it invalidates their results. His experiment proved that the death of tissues and cells is mistakenly considered to be the isolation of the virus.

The computer software can produce many possible combinations depending on variations in the methods used. They arbitrarily select some of these variations and call them variants, but none are found in nature. They never prove the existence of a single viral particle. Their whole process meets the definition of divination, which is not limited to foretelling future events but also includes the practice of determining the hidden significance or cause of events by a supernatural, or unscientific, means.

The Bible describes divination and sorcery as detestable things: "When you enter the land which the Lord your God gives you, you shall not learn to imitate the detestable things of those nations. There shall not be found among you anyone who makes his son or his daughter pass through the fire, one who uses divination, one who practices witchcraft, or one who interprets omens, or a sorcerer, or one who casts a spell, or a medium, or a spiritist, or one who calls up the dead. For whoever does these things is detestable to the Lord; and because of these detestable things the Lord your God will drive them out before you. You shall be blameless before the Lord your God. For those nations, which you shall dispossess, listen to those who practice witchcraft and to diviners, but as for you, the Lord your God has not allowed you to do so. – Deuteronomy 18:9-14.

Virology is not the only medical field using divination. Biology, in so far as cell theory is concerned, is also based on a form of divination. The current model of the generalized cell is based primarily upon artifacts produced by electron microscopy. Since many of the cell's features are artifacts produced by this process, the function of these features must be

fictitious. One can only conclude that the current working model of the generalized cell is a misrepresentation.

Virologists claim that their fictitious viral particles hijack cellular ribosomes to replicate. However, what are called ribosomes have not been proven capable of performing this function. In regard to ribosome theory, and I quote from "The Living Cell" by Dr. H. Hillman, "this name is given to the granules seen on electron microscopy between the layers of the endoplasmic reticulum and also to a particular subcellular fraction containing 40 to 50% RNA. It is generally believed that RNA and its chemical function reside in the former locality in vivo. The particles cannot be seen by light microscopy, and in our opinion there is insufficient evidence of subcellular localization of biochemical activities."

The author goes on to say, "if the endoplasmic reticulum is an artifact due to deposit of the cytoplasm it is very likely that the ribosomes are also a deposit. They may consist of RNA and protein in the separated fraction, but may well not be the same material as is seen on electron micrographs. If RNA were lining a reticulum one might see this on ultra-violet microscopy as dark channels permeating the cytoplasm. Where the endoplasmic reticulum is believed to be restricted to a small region of the cell, that part should absorb much more ultra-violet light, due to the higher concentration of RNA. We are not aware of such appearances having been seen, nor have we seen it ourselves in neurons."

Hillman also points out that two major morphological findings, concerning the double-layered membrane and cristae, are also suspect because they are derived from subcellular fractionation and electron microscopy, and that the Golgi apparatus is an artifact as a consequence of the uncertainty of exactly what it is due to inconsistent results from various observations. Similar problems arise in defining lysosomes and the nucleoplasm. The proper conclusion is, as stated by Dr. Hillman, "that the endoplasmic reticulum, the Golgi apparatus, the lysosomes, the nuclear pores, the cristae of the mitochondria, and the 'trilaminar' appearance of the cell, nuclear and mitochondrial membranes – as opposed to the membranes themselves – could not exist in living cells; they must be artifacts arising during preparation for electron microscopy."

Therefore, not only is virology a pseudoscience, so is cell biology. Both are forms of divination, and these two pseudosciences work hand in hand to falsely justify the need for various medical treatments, including vaccination.

The theory that the body has an immune system that operates by producing specific antibodies to specific virus particles has never been proven. To accomplish this, one would first have to prove the existence of viral particles, which has not been done. The body does have defense mechanisms, or else it would not attempt to remove whatever does not belong in the body; that they are specific to individual types of viral particles and not nonspecific (in that they function against any toxin) is based on nothing more than conjecture. Immunology is another form of divination used to justify the use of vaccines. Injecting people with what are claimed to be viral particles with added adjuvants to stimulate an immune response and teach the body to neutralize specific viral particles is sorcery.

The COVID-19 mRNA injectables are not traditional vaccines. The medical complex departed from its traditional methods to provide a treatment for what they claimed was a new virus. They even had to change the definition of the word "vaccine" to incorporate their use. The COVID-19 injectables are protected by patents. The companies that produce them make claims about their contents, but the package insert is intentionally left blank. They are authorized for emergency use, and the companies have immunity from liability. Those who take them assume all risk. Only the manufacturers know their ingredients. To take any of these COVID-related products is against scriptural principles to "prove all things" and reject "presumptuous sins."

Furthermore, independent researchers have conducted analyses of the contents of the COVID-19 vaccines and determined them to be cytotoxic. But their research is rejected, not because it is unscientific, but because it does not conform to the official consensus, which has nothing to do with science. The problem is that virologists, immunologists, and vaccinologists have abandoned science to become sorcerers and diviners. Some of them know they are tools of the devil; others have been deceived. But this is inconsequential because the fruits of their labors are all the same.

The PCR test is not a diagnostic test. It is a procedure developed by Dr. Kary Mullis to amplify DNA sequences, not whole genomes. It is a manufacturing technique that starts with one molecule. Each time a molecule is cycled, the number of molecules doubles. Mullis explained that there are very few molecules that each person does not have at least one of in their body. Enough cycles will produce millions of molecules that never existed in the person from whom a sample was taken. The claim that results from a specific number of cycles means that a whole virus is present in a person is nonsense. The virologists simply misinterpret the results from the PCR procedure to create the illusion that someone is infected with an active infectious agent. In

essence, they divine the presence of a virus because their procedure is not scientific. This is consistent with their other forms of divination, whereby they employ various means to gain knowledge unavailable through scientific methods.

Many people have been misled by the misuse of the PCR procedure into believing they have become infected with a dangerous virus. They have been deceived by virologists using divination, which is the principle means used by Satan to mislead the world. This particular form of divination has induced a mass psychosis in society. The soothsaying virologists claimed that the virus would kill millions, and by that means, they drove populations into the hands of the sorcerers and their dangerous potions, which they call vaccines. The Scriptures warn believers to "be sober-minded; be watchful. Your adversary the devil prowls around like a roaring lion, seeking someone to devour." – 1 Peter 5:8.

The practice of sorcery is listed among the works of the flesh. (Galatians 5:19-21) It is an abomination before the Lord. (Deuteronomy 18:10-14) Vaccination is sorcery. It is the cup that is passed from the diviner to the sorcerer – the cell culture – to which are added dangerous adjuvants for injection into the deluded masses. The COVID vaccines take sorcery to a higher level. They are said to contain the necessary ingredients to cause cells to produce the very poison contained in the virus itself, after which the immune system is said to produce antibodies against the virus. This is simply more soothsaying. No virus has ever been proven to exist or been isolated. What virology calls "isolation" does not isolate anything. Human cells do not function according to the institutional models, and neither do the body's defense mechanisms, which the virologists, biologists, and immunologists call the immune system.

Ours is a time of great wickedness, not unlike the time of the Biblical prophets, when abominable practices such as sorcery, divination, and soothsaying were rampant. The presence of these practices is always indicative of and answers to the degree of wickedness in society. The spirit that operated in the sons of disobedience in former times is the same spirit that operates in them today. The only distinction is that the technology available today is far more advanced than in former times. However, the problem is not in the technology but rather in its abuse. Modern divination abuses science and technology to undermine and eliminate the position of the creator and his role in the lives of individuals.

It should come as no surprise that the virus theory and the theory of evolution come from the same people. They are identical insofar as both contain the idea of something evolving from one

form into another. The virus theory, like its companion, the evolution theory, has never been proven. Although the evolution theory encompasses a far greater spectrum than the virus theory, one could reason that the virus theory is simply a subset of all that evolution is said to encompass. Both dispense with the idea of a supreme creator and lawgiver and defer to random chance, but no such thing as chance is ever explained, except within the context of ignorance. They claim, without any scientific proof whatsoever, that viruses undergo evolution and natural selection, just like cell-based life, in direct denial of Genesis 1:1 – “In the beginning God created . . .”

The prophetic book of Revelation places sorcerers and liars outside of the kingdom of God. (Revelation 22:15) They will be consigned to the darkness because they chose to live in darkness. God’s people are commanded to dwell in the light: “Your word is a lamp to my feet and a light to my path.” (Psalm 119:105) The light of God manifests itself by means of the Holy Spirit, of which the body is the temple. (1 Corinthians 3:16–17) The Holy Spirit is the helper sent from God to guide his people into all truth. (John 14:26; 16:13) God’s people are commanded not to grieve the Holy Spirit by engaging in the works of the flesh. (Ephesians 4:30; Galatians 5:19–21) Seeing as the body is the temple of God, wherein he dwells in spirit, it should remain undefiled by the potions of sorcerers.
